Logan City business/projects: Sid Bodrero

Richard discussed the work that has been going on between 6th and 7th North, reinforcement of banks here and in a few other areas, appreciation for Logan City and their help with these projects.

- 100 S Replaced with new backup system, reinforced bank on North side, both sides approx. 50 ft.
- 500 N 200 W On West side of bank eroding into yard, contractor (K. Petersen) fixed with help from homeowner. Grate replaced as well.
- 1100 N to 1800 N tree removal by Steve Buttars, on 1800 N incident with a car and tree, removed by Total Tree Care
- 1100 N backup taken out, bank reinforced
- 900 N Logan City replaced grate
- 600 N bank eroding on East side

Annual Clean up from 300 S to 1800 N each year, tree removal

Cleaning/tree removal/widening: Sid Bodrero

- 1800 N on West side is out for bid right now
- Beaver at the Eagles Lodge have been removed again, trees will be removed on both sides to keep them from coming back.

Water Outlook: Gordon Coulsen

- Franklin Basin's at 117-124% as snow has been wetter/heavier this year, expect some flooding as the ground is more saturated.
- Discussion on Measuring Devices by 2029 as a State Law, we are still looking into what this might/may look like and the expense of it.
